President's Message

The Pasadena Chamber wants to be supportive of our local public school and, with our Workforce Development Committee explores many avenues for support and input to the **Pasadena Unified School District**. Representatives of the Chamber have served on budget and oversight committees and advisories for the many College and Career Academies. We even provide donations to support Pasadena High School from the proceeds of our New Year food vending fundraiser.

This past spring, the Chamber, following direction from our board, piloted a new program at Eliot Middle School in PUSD. Working with our member **Ideal Youth** and our Workforce Development Committee, we devised a series of workshops on financial literacy, work readiness and computer safety for 6th graders at the school.

Called \$ixth Grade ¢ents, the program featured **Wells Fargo** local bank staff members' excellent introduction to basics of budgeting and saving for the future, how banks work and how to safeguard your earnings. **YWCA Pasadena-Foothills** helped students understand how internet and mobile phone applications can lead to unsafe situations, and how to avoid trouble online. They also discussed how to report behavior that is uncomfortable or potentially dangerous.

One of the highlights of the spring program was the appearance of 2014 **Tournament of Roses** Princess Kayla who talked to the young people about appropriate dress and behavior and making a good impression on others. Ideal Youth also led the students in a stock market exercise and explained how investing early can pay big dividends in the future.

We are very pleased with the program and the reception from students and teachers. \$ixth Grade \$\psi\$ents is still in the pilot stage. We are returning to Eliot this fall to fine-tune the program before we offer \$ixth Grade \$\psi\$ents to other PUSD middle schools.

City of Pasadena and Pasadena Chamber Host 2nd Economic and Business Summit October 23rd

Pasadena Mayor Bill Bogaard will provide a brief update on City finances and priorities.

Pasadena Chamber Membership Investment Increases 15%

In 2008, the Chamber Board decided to institute a 25% increase in the membership investment schedule, to be implemented over three years. Prior to that, Chamber dues had not been increased for at least ten years. The first year's increase was implemented in July, 2008. With the economic collapse that November, the additional 15% was suspended indefinitely.

At the recommendation of the CEO, our Member Services Committee and the Chamber Board determined that, if the Pasadena Chamber is going to continue to grow and expand our offerings to serve the members, we need to increase our revenues.

Over the past three years, we have nearly doubled the number of significant events and activities offered to engage and support our member companies. The Chamber now presents three restaurant-related events each year along with the *Taste of Pasadena* in September. We organize the annual *Economic and Business Summit* and the *ACCESS: Opportunity Procurement Forum* that links large corporate members with small businesses. This year, we also sponsored the first mega marketing event at PCC.

Recognizing the need for additional staff support, the Committee and the Board voted to reinstate the additional 15% increase approved six years ago, beginning September 1, 2014. The increase only applies to the base dues rates so that no Chamber member will see an increase of more than \$90 per year. For most Chamber members the increase will be between \$35 and \$45 per year. This rate is expected to remain in effect until 2019.

As difficult as the decision has been, the Chamber is a small business, too. We have to balance budgets, allocate resources and motivate staff. Like you, we have faced increases in rent, services, equipment, insurance and more. We also do our best to pay Chamber staff a fair wage and provide basic benefits for the hard work we expect.

Even with the increase in membership investment in the Pasadena Chamber, our rates will remain significantly below those of our peers in Southern California. The Pasadena Chamber's base rate for a small business will be \$265 per year beginning September 1st. As a comparison, most chambers our size, serving communities like ours, charge at least \$300 per year for their basic small business membership, and some begin at \$500. AND, we offer a much more aggressive schedule of events and member support activities. The Pasadena Chamber Board was intent on keeping our dues increase modest and only raised costs to meet our financial obligations and maintain our solid financial foundation.
