(Any Retailer, restaurant, service business, contractor, etc. employing less than 100)

Major Employers (100 or More Employees)

Major employers are asked to invest a minimum of \$830 base plus \$1 per employee over 100

Hotels

Base of \$2200, plus \$2 per room.

Motels

Base of \$775, plus \$2 per room.

Condos/Apartments

Base of \$500, plus \$3 per unit.

Churches

\$425 annually, with no processing fee.

Real Estate

Base of \$330 per office for the broker and up to two employees. Independent contractors (Realtors) can be added as individual members for \$250 each with full privileges if associated with base member.

Professional Services(Doctors, Lawyers, CPAs)

Base of \$330 per office plus \$150 for each additional listed partner in the office.

Non-Profit Community Based Service Providers (10 Employees or Fewer)

\$230 annually, with no processing fee.

Underrepresented (Minority) Small Business

\$100 annually, with no processing fee. 10 or fewer employees. New members only.

Individuals

\$150 annual investment. Available only to persons not engaged in active commerce.

Home Based Business

\$280 annual investment. Business must be residence based. Cannot be main business if co-owned with a non-home based business.

Second Business

\$165 annual investment.

Special Introductory Rate for Members in Good standing of Other Local Chambers

\$250 annual investment for first year.
