By reviewing the status of current programs, assessing their efficacy in supporting our mission, and looking to the future needs of the community, the following objectives from past years were revisited, modified and additions adopted for calendar year 2016.

- We will achieve this by increasing value to our members by serving their needs, supporting their interests and providing a forum for advice, as well as networking, promotional, and advertising opportunities.
- We will help our members develop and maximize their business performance by providing opportunities for our large and small members to interact for the benefit of both and by supporting our local economy in collaboration with the City of Pasadena.
- We will represent the best interests of our members by serving as an effective advocate before local, regional, and federal governing bodies.
- We will champion the cause of helping local students, displaced workers and others to become employed in the local economy by connecting them with education, training and opportunities for gainful employment.
- We will do this by enhancing our support services and resources for members by using state-of-the-art computer, internet and mobile technology.

MEMBER SERVICES Vice-chair: Joan De Souza, Joan's Candles and Home Décor

Member Services Work Program:

- The Chamber Board will actively participate in Chamber and member events and activities.

ADDITIONS FOR 2016:

- Explore creating private, member-only pages on Facebook and Linked In. Explore creating a member-only section on the website (with Technology Committee).
- The Chamber will host member recruitment events by industry sector.

ECONOMIC AND BUSINESS DEVELOPMENT COMMITTEE Vice-chair: Karl Bird, Jet Propulsion Laboratory

We will help our members develop and maximize their business performance by providing opportunities for our large and small members to interact for the benefit of both and by supporting our local economy in collaboration with the City of Pasadena and others.

Business Development Work Program:

- The Chamber will encourage members to do business with one another, collaborate and interact.
- The Chamber will disseminate bidding, contracting and rfp information and opportunities to the membership.
- The Chamber will continue to reach out to important local stakeholders to assess economic health, needs and prospects.

The Chamber will represent the interests of our members by serving as an effective advocate before local, regional, state and federal governing bodies.

Advocacy Work Program:

- The Chamber will remain a vigilant participant in legislative, regulatory, permitting, development tax and fee proposals that can impact our membership and take positions on other items that may impact our member businesses.
- The Chamber will use e-mail action alerts to mobilize the membership on important issues and distribute its legislative
 platform and positions on issues to the membership in an easily readable form.
- The Chamber will inform the membership about our legislative platform and positions on issues through the e-Bulletin.
- The Chamber will track issues and report to the membership on positions and effectiveness of our platform.

WORKFORCE DEVELOPMENT Vice-chair: Ishmael Trone, F & M Business Center

The Chamber will help students, displaced workers and existing underskilled workers to become contributing members of Pasadena's workforce. We will be a recognized resource for addressing workforce development needs in the local community.

Workforce Development Work Program:

- The Chamber will connect community resources to help ensure effective training and educational opportunities exist for prospective employees and others.
- The Chamber will convene a meeting of stakeholders to discuss and strategize about summer internships for youth.
- The chamber will continue and expand \$ixth grade \$\psi\$cents financial literacy for sixth graders in Pasadena Unifieds.

ADDITIONS FOR 2016:

- The chamber will work with Economic and Workforce Development Department at Pasadena City College to create collaborations in the classroom and the workplace.
- The Chamber will facilitate connections between business and local public high schools, finding classroom speakers and job shadow opportunities for students. We will identify, train and place interns from College and Career programs.
- The Chamber will convene a meeting of stakeholders to strategize, educate and attract business to support opportunities.

TECHNOLOGY Vice-Chair: Justin Tsui, TeamLogic IT

State-of-the-art technology enhances support services provided by the Chamber, expands resources available to members and staff and improves the effectiveness of the Chamber.

At your Chamber, we recognize that the only way to achieve the goals and objectives of the strategic plan is to invest in technology that can meet the needs of our members, staff and community.

Technology Work Program:

- Chamber will promote our mobile applications to better serve and drive business to members.
- Using internet survey tools, the Chamber will assess member attitudes, interests and technology needs.
- The Chamber will use social media to inform our membership, publicize events and activities and promote our members.
- The Chamber will build *Grow With Us*, our business recruitment program, to the website.

ADDITIONS FOR 2016:

- The Chamber will integrate some technology-themed workshops into the Brown Bag Lunch workshop series.
- The Chamber will consider hosting a meet-up workshop where tech providers can meet with members to solve problems.



Focus on Quality of Life

Since 1888, the Pasadena Chamber of Commerce has contributed to the quality of life in Pasadena as it helped raise money for City Hall, our first library and hospital and the Colorado Street Bridge. We helped establish the Tournament of Roses and guided the economic growth of Pasadena. That tradition continues with the involvement of Chamber members in all facets of our community. EXECUTIVE COMMITTEE AND TASK FORCES

- Promoting Buy Pasadena and encouraging our residents and workers to do business with Pasadena Chamber member companies;
- Taxation, regulation and the cost of doing business;
- Health care requirements and impact on business;
- Sustainability and climate change legislation and its impact on local businesses and our economy;
