Originally incorporated as the Pasadena Board of Trade in 1888, the Chamber of Commerce played a pivotal role in the development and funding of Pasadena's schools, libraries, hospital, and city hall.

In 1890, the Board of Trade helped establish the Tournament of Roses Association, which assumed the responsibilities for the annual Rose Parade. The Board raised money for the Colorado Street Bridge and proposed creation of our municipal electric and water companies.

After 27 years of operation in New York, Honeybee Robotics opened its West Coast operations facility with the help of the Pasadena Chamber of Commerce. We decided to open a facility in Pasadena and began talking to the Chamber staff about the best site to locate our company. 1920s, the Chamber passed the bond measure that paid to construct our civic center, the Pasadena Public Library, City Hall and the Civic Auditorium. It continued to play an important role in the city's growth and development throughout the 20th century. The Chamber was

instrumental in establishing Pasadena as a headquarters city for companies such as Parsons, Western Asset Management and Kaiser Permanente. Chamber advocacy was crucial to bringing the Gold Line light rail to Pasadena.

Major Employers (100 or more employees)

Major employers will be asked to invest a minimum of \$690 base plus \$1 per employee over 100. Hotels

Base of \$1785, plus \$2 per room.

Motels

Base of \$630, plus \$2 per room.

Condos/Apartments

Base of \$440, plus \$3 per unit.

Real Estate

Base of \$265 per office for the broker and up to two employees. Independent contractors (Realtors) can be added as individual members for \$125 each with full member privileges as long as they remain associated with the base member.

Professional Services (Doctors, Lawyers, CPAs)

Base of \$265 per office plus \$125 for each additional listed partner in the office.

Churches

\$375 annually, with no processing fee.

Community Based Non-Profit Service Providers (ten employees or fewer)

\$190 annually, with no processing fee.

Individuals

\$125 annual investment. *Available only to persons not engaged in active commerce.*

Home Based Business

\$230 annual investment. *Business must be residence based. Cannot be main business if co-owned with a non-home based business.*

Second Business

\$135 annual investment

Special Introductory Rate for Members of Other Local Chambers

\$200 annual investment for one year. *Members in good standing of other local chambers enjoy a one-year introductory rate.*
