

# The Pasadena Chamber of Commerce and Civic Association

Originally incorporated as the Pasadena Board of Trade in 1888, the Chamber of Commerce played a pivotal role in the development and funding of Pasadena's schools, libraries, hospital, City Hall and the iconic Colorado Street Bridge.

In 1890, the Board of Trade proposed the Tournament of Roses Association, which is responsible for the Rose Parade and Rose Bowl game. The Board raised money for the Colorado Street Bridge and proposed creation of our municipal electric and water companies.

In 1919, The Board of Trade became the Pasadena Chamber of Commerce. In the 1920s, the Chamber passed the bond measure that paid to

construct our Pasadena Public Library, City Hall and Civic Auditorium. It successfully advocated for creation of the Pasadena Freeway.

Base of \$440, plus \$3 per unit.

Base of \$265 per office for the broker and up to two employees. Independent contractors (Realtors) can be added as individual members for \$125 each with full privileges if associated with base member.

## Professional Services (Doctors, Lawyers, CPAs)

Base of \$265 per office plus \$125 for each additional listed partner in the office.

## Churches

\$375 annually, with no processing fee.

## Community Based Non-Profit Service Providers (10 employees or fewer)

\$190 annually, with no processing fee.

## Minority-Owned Small Business

\$100 annually, with no processing fee. 25 or fewer employees. New members only.

## Individuals

\$125 annual investment. *Available only to persons not engaged in active commerce.*

## Home Based Business

\$230 annual investment. *Business must be residence based. Cannot be main business if co-owned with a non-home based business.*

## Second Business

\$135 annual investment
