

President's Message

Is Pasadena losing its uniqueness?

In August, the Chamber lost three of our restaurant members to closings.

POP Champagne Bar and Restaurant, Central Grille and Big Mama's Rib Shack each ended significant tenures among Pasadena's restaurant community. Late in August, Robin Salzer announced he is closing **Robin's Wood Fire BBQ** in east Pasadena and retiring. Robin's catering business will continue under the ownership of Camillo DiMasi, who has overseen catering for Robin's for years. The restaurant will close, though Mr. Salzer has said he is negotiating with a potential tenant, so another eatery may occupy the Foot-hill/Hastings Village site.

Each of the business owners cited higher costs as the reason behind closing. Even Robin's had cut operating hours to three days per week at the restaurant to maintain profitability. Central Grille ownership had the opportunity to abandon their lease without penalties and jumped at the chance.

Each of these restaurants were locally owned. Each was unique in the Pasadena dining environment. Each faced significant competition. And, each could no longer cope with the rising cost of doing business here.

There was not one single factor. It wasn't only rising rents, or minimum wage increases, or material and food costs or decreased business due to competition in Pasadena and surrounding cities. The result, however, is that we now have four fewer distinctly Pasadena restaurants.

We are still fortunate to have more than 600 restaurants to choose from—many with great food locally, regionally and nationally owned.

We can't legislate who opens in what space, but maybe Pasadena can identify spaces where locally owned businesses can get started, grow and prosper. Are there ways to assist locally owned businesses that may be in peril? Can we be creative to keep Pasadena unique?

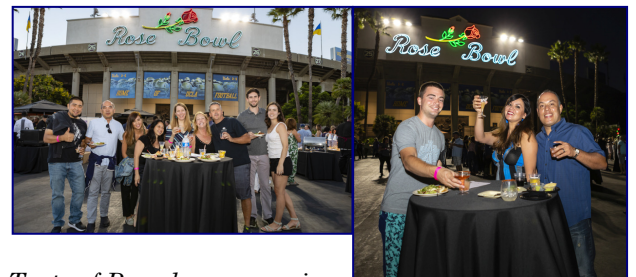
Taste of Pasadena Returns to the Rose Bowl October 10th

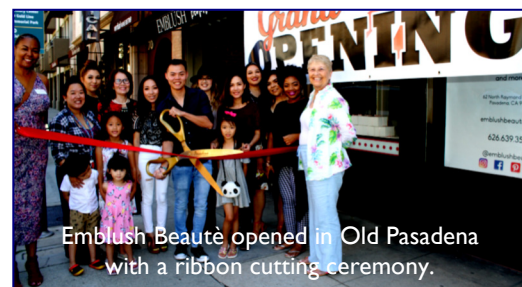

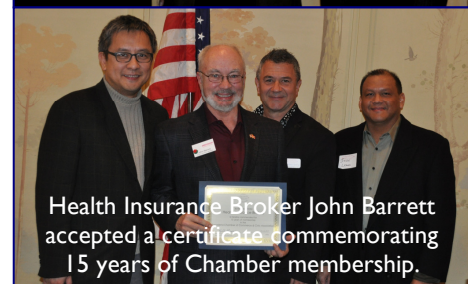

Sexual Harassment Awareness Workshop October 15th Presented by Hunt Ortmann FREE for Pasadena Chamber Members-Space is Limited, Sign Up Now!

California law newly requires an employer who employs five or more employees, including temporary or seasonal employees, to provide at least two hours of sexual harassment training to all supervisory employees and at least one hour of sexual harassment training to all nonsupervisory employees by January 1, 2020, and once every two years thereafter.

Pasadena Chamber of Commerce member **Hunt Ortmann Palffy Nieves Darling & Mah, Inc.** will provide interactive, in-person training to satisfy the requirements under California law in an informative and informal format for all employers **FREE for Pasadena Chamber members**. The two sessions will include training sessions for both supervisory and non-supervisory employees, as required under California law.
